CHANGES COMING FOR BARGAINING UNITS

In December 2003 the National Assembly adopted Bill 30 (LRQ2003, chapter 25) - An act respecting bargaining units in the social affairs sector and amending the Act respecting the process of negotiation of the collective agreements in the public and parapublic sectors.

As you may have heard through the media or other sources, this law introduces a union representation system for establishments of our network. With your pay stubs of April 1st, 2004, you will receive an information pamphlet from the Ministry intended to provide general information to employees about this law.

The purpose of this article is to put this information into context. The law provides that each establishment may only have up to four accreditations grouped into four classes of personnel (clinical, nursing, administrative and technical). There is a possibility that our legal merger creating a single Batshaw corporation and employer may take place in the next months. If this occurs, the process to integrate accreditations will follow immediately for the whole organisation.

If the merger does not occur in the next months, there will be a process to integrate accreditations for each establishment that currently has more than three accreditations. In our case, this will involve Ville Marie Child and Youth Protection Centre and Shawbridge Youth Centres. The process of integration will have to be done again for the entire organization, after the

The law also introduces a concept of accreditation per region. This complicates somewhat the process of integration, given that we have points of services in three regions (Montreal, Laval and Laurentides). We hope to be able to negotiate bridges between accreditations of each region to function as if we were one region. Many establishments will begin the process of integration in April 2004. Depending on our legal merger process, we may begin ours in August or late fall 2004.

The law also decentralizes 26 matters which will be negotiated locally. However, this will only begin once the process of integrating accreditations is completed. In due time, we will provide the necessary information on these issues. For now, current working conditions will remain unchanged until a new provincial collective agreement is promulgated and until the local negotiation process is terminated, which could take up to two years.

We will be meeting all union executives on April 13, 2004, for an exchange on the impact of the law in Batshaw. We also intend to hold general information meetings for employees in May or June 2004 at 6 Weredale Park, Dorval and Prévost. We will do our utmost to keep everyone informed on the impact of the law before the integration process is initiated.
