YOUTH PROTECTION ACT TO BE REVISED

The Ministry of Health and Social Services (MSSS) decided in 2001 to revise the Youth Protection Act and created a committee of experts to prepare recommendations. In November 2003 the committee deposited their report. The MSSS then conducted extensive consultations on the 57 recommendations. Over 900 individuals representing diverse groups throughout Quebec expressed their point of view. On October 20, 2005, An Act to Amend the Youth Protection Act was tabled in the National Assembly. The Bill will be reviewed by a Parliamentary Commission beginning January 24, 2006, and could be voted on by spring. In parallel, the Ministry of Justice undertook a review of judicial proceedings related to youth protection cases to modernize the court process.

Major changes include revision of section 38 to bring greater clarity on what situations require youth protection intervention. The motives for intervention have been grouped under six headings: abandonment, neglect, psychological ill-treatment, sexual abuse, physical abuse, and serious behavioral disturbance.

The Bill affirms that children should remain with their families. When this is not possible placement, with extended family members should be considered. To facilitate this, the Bill proposes a new placement option called subsidized tutorship.

To provide greater stability for children who are in placement, the Bill requires development of a permanency plan after 12 months of placement for children under two years of age; after 18 months of placement for children between two and five; and after 24 months of placement for children six years and older. This plan must be sanctioned by the Court.

The Bill favors a consensual approach to decision-making with families and reserves access to court for the most difficult cases. It provides for interim agreements; greater use of *intervention terminale*; and extension of urgent measures to 48 hours. Lastly the Bill provides for greater access to information on children held by other establishments; enhanced ability for protection workers to share information with others; revised rules extending conservation of protection dossiers and the creation of a provincial register that would permit the DYP to know if a child had ever been signaled before in any part of the Province. We will keep you posted on the legislative process as it unfolds.

SUICIDE PREVENTION WEEK

The Suicide Prevention Protocol has been in application in residential programs since September 2002. First-level

interveners were trained to use the screening checklist and implement the procedures. We are in the process of expanding application to the Social Emergency Service; Reception and Treatment of Signalements; *Vérification sur terrain*, and Foster Care over the next year.

The protocol enhances communication between interveners to reduce the isolation felt by clients who manifest suicidal behavior and of the staff dealing with it.
